These Terms of Use (the "Agreement") are applicable to the: (i) services, (ii) website(s), (iii) content, (iv) databases and (v) information (collectively referred to as the "Services") together with the agreements and software provided by EMXPRO Limited ("EMPEROR Xpro") to which you may have access either by using EMPEROR Xpro's website or, upon request, in hard copy. The content and information included in these Services are provided by EMPEROR Xpro and its third party suppliers (collectively, the "Information Providers"). These Services are made available by EMPEROR Xpro subject to the terms and conditions stated below.

Agreement
